4. Pre- bid meeting shall be held at Lo- Ghekar Damodarkunda Rural Municipality at 2078-02-02 (i.e. 16-05-2021) 13:00 hours.

Separate Electronic Bids must be submitted to the Lo-Ghekar Damodarkunda Rural Municipality, office of Rural Municipal Executive, Charang, Mustang through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 2078-02-14 (i.e. 28-05-2021) 12:00 hours. Under the Single Stage Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the price Bid, both in turn enclosed on one sealed envelope. Bids will be evaluated on the basis of each contract.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2078-02-14 (i.e. 28-05-2021) 13:00 hours at the Lo-Ghekar Damodarkunda Rural Municipality, office of Rural Municipal Executive, Charang, Mustang. Bids must be valid for a period of 120 days after bid opening. Bid Security amount must be as per above table and shall be valid for 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date.
8. Bids should comply in all respects with the Instruction of Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
